

BARGAIN AND SALE DEED

KNOW ALL MEN BY THESE PRESENTS, that the City of Klamath Falls, a municipal corporation, hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto Dennis Paddock and Michella Paddock, Husband and Wife

hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the City of Klamath Falls, County of Klamath, State of Oregon, described as follows, to-wit:

Beginning at the North East corner of Lot 2, Block 13, Fairview Addition to the City of Klamath Falls; thence S 89° 55' E, 44.0 feet; thence South, 50.0 feet; thence N 89° 55' W, 44.0 feet; thence North, 50.0 feet to the point of beginning, free of all encumbrances except reservations, restrictions, easements and rights-of-way of record and those apparent upon the land.

To have and hold the same unto the said grantee and grantee's heirs, successors and assigns forever.

The true and actual consideration paid for this transfer, stated in terms of dollars, is Six Hundred Forty and no/100-----Dollars (\$ 640.00).

In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.

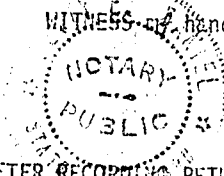
