

# SATISFACTION OF MORTGAGE

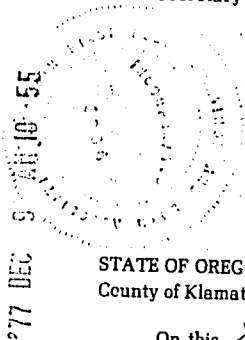
