- 5. Not to permit any tax, assessment, lien, or encumbrance to exist at any time;

- To keep all buildings unceasingly insured during the term of the mortgage, company or companies and in such an amount as shall be satisfactory to the policies with receipts showing payment in full of all premiums; all such insurance shall be kept in force by the mortgagor in case of forcelosure un

- Mortgagee shall be entitled to all compensation and damages received under right of eminent domain, or for any security voluntarily released, same to be applied upon the indebtedness;
- 9. Not to lease or rent the premises, or any part of same, without written consent of the mortgagee;
- To promptly notify mortgagee in writing of a transfer of ownership of the premises or any part or interest in same, and to furnish a copy of the instrument of transfer to the mortgagee; a purchaser shall pay interest as prescribed by ORS 407-079 on all payments due from the date of transfer; in all other respects this mortgage shall remain in full force and effect.
