A hearing was held in this matter at Klamath Falls, Oregon, on October 19, 1977, at which time the applicant requested that the hearing be continued. The hearing was reconvened on November 15, 1977, pursuant to notice given in conformity with Ordinance No. 35, Klamath County, before Klamath County Hearings Officer, Del Parks. The applicant was not present. The Klamath County Planning Department was represented by Carl Shuck. The Hearings Reporter was Isabel Rodriguez.

The applicant requested that his application be withdrawn. Evidence was presented neither on behalf of the Department nor on behalf of the applicant. There were several adjacent property owners present.

IT IS HEREBY ORDERED that the applicant is barred from application for a Conditional Use Permit for a period of one year from the date of this Order.

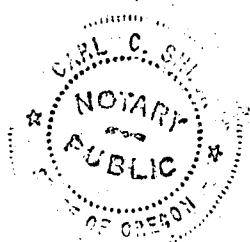
