26 27 28 1. The neighborhood is a prezoning development and there are in the neighborhood exceptional circumstances in that it is common within the area to build within one or two feet of the property line.

9 2. If the Variance was not granted, the applicant would
10 not be able to enjoy his property to the same extent that the other
11 persons within the neighborhood are presently utilizing their property.
12 3. The use would not change, it would merely be enhanced
13 by the use of the covered structure.

14 4. The Variance will not be materially detrimental to the
15 public health, safety, or welfare of the adjoining property or the
16 immediately neighborhood.

5. The Variance requested is the minimum variance necessary to alleviate the hardship as it now exists.

The Hearings Officer, based on the foregoing Findings of Fact, accordingly orders as follows:

That real property described as the

"that parcel of land bordered by Klamath Theaters to the north and more particularily described as Lot 37 of Perry's Addition to Lloyd's Tract, situated in the NE¼, SW¼, Section 11, Township 39S, Range 9 E.W.M. Klamath County, Oregon."
