Klamath County Planning Findings of Fact and Order

A hearing was held in this matter at Klamath Falls, Oregon 8 on November 14, 1977, pursuant to notice given in conformity with 9 10 Ordinance No. 35, Klamath County, before Klamath County Hearings 11 Officer, Del Parks. The applicant was present. The Klamath County 12 Planning Department was represented by Carl Shuck. The Hearings 13 Reporter was Isabel Rodriguez.

Evidence was presented on behalf of the Department and on 14 behalf of the applicant. There were several adjacent property owners 15 present who stated they had objections to the proposed Variance 16 requested by the applicant.

The hearing was then closed and based upon the eivdence submitted at the hearing, the Hearings Officer made the following findings of fact:

FINDINGS OF FACT:

1. In connection with the Variance, the RD 8,000 Zone provides that no more than one single family dwelling be allowed on a single lot, and there is already a dwelling which predated the zoning.

11 2. The configuration of the lot is exceptional and extra-12 ordinary; it is not a configuration that is generally applicable to 13 other property in the area.

14 3. Unless the Variance is granted, the lot is unbuildable 15 and the applicant is deprived of a property right possessed by 16 other owners in the same vicinity and zone.

4. The Hearings Officer was unable to decide if the 18 Variance sought by the applicant is the minimum that would eliminate the hardship.

5. The Hearings Officer feels that because of the configuration of the property, its location to two streets that are fairly well traveled, and the location of power lines, the granting of the Variance would be materially detrimental to the public health, 23 safety, and convenience of the immediate neighborhood, and therefore, 24 the Variance is denied.

The Hearings Officer, based on the foregoing Findings of Fact, accordingly orders as follows:

That real property described as the
