ORDINANCE NO. 219

6 WHEREAS, the Common Council of the City of Merrill, Oregon,
7 hereby finds that the area described below, also described as East Merrill
8 Area, should be annexed due to the order signed declaring the area a Health
9 Hazard on the 29th day of July, 1977, by the State Health Division, and

10 WHEREAS, the plans, specifications and time schedule have been
11 approved by the Oregon State Health Division, and

12 WHEREAS, the Common Council of the City of Merrill has deter-
13 mined that such health hazard can be removed or alleviated by sanitary,
14 water or other facilities ordinarily provided by said City, now, therefore,

15 THE CITY OF MERRILL ORDAINS AS FOLLOWS:

16 Section 1: That the area known as East Merrill, described
17 as follows:

18 Beginning at the Intersection of the Southerly right-
19 of way line of the Burlington-Northern Railroad and the
20 East City limits line of the City of Merrill in Section
21 1, Township 41 S., Range 10 E.W.M.; thence East along the
22 Southerly right-of-way line of said railroad to its inter-
23 section with North-South centerline of said Section 1,
24 Township 41 S., Range 10 E. W.M.; thence South along the
25 North-South centerline to the Northeast corner of Sunshine
26 Tracts, a recorded subdivision in Klamath County, Oregon;
thence S 89° 51' E. 193.9 feet; thence South to the South
Section line of Section 1, Township 41 S., Range 10 E.
W.M.; thence East along the South line of said Section 1,
162.1 feet; thence South 367 feet; thence West to the
East city limits line of the City of Merrill; thence North
along the East city limits line to the South line of

1 Terwilliger Subdivision, a recorded subdivision in
2 Klamath County, Oregon; thence East along the South line
3 of Terwilliger Addition and its extension to the East
4 City limits line of the City of Merrill; thence North
5 along the East City limits line of the City of Merrill
6 to the point of beginning.

7 excepting the following described area:

8 Starting at the one-quarter section corner common to
9 Sections 1 and 12, Township 41 South, Range 10 East,
10 W.M.; thence East along the northern boundary of
11 Section 12, Township 41 South, Range 10 East, W.M.,
12 for a distance of 356 feet; thence South 367 feet; thence
13 West to the east city limits line of the City of
14 Merrill; thence North along the East city limits line
15 to the Northern boundary of Section 12, Township 41
16 South, Range 10 East, W.M.; thence East along said
17 northern boundary of Section 12 to the point of
18 beginning.

19 shall be annexed to the City of Merrill in accordance with ORS
20 222.850 to 222.915.

21 Section 2: The City of Merrill shall provide the necessary sewer
22 service in order to alleviate the health hazard in the East Merrill area.

23 Section 3: The City of Merrill hereby adopts the Plans,
24 Specifications, and Time Schedule as approved by the Health Division on
25 July 29, 1977.

26 Section 4: The immediate enactment of this ordinance being
deemed necessary for the public welfare, an emergency is declared to
exist and this ordinance shall be in force and effect from and after its
passage by a three-fourths aye and nay vote of the Common Council and its
approval by the Mayor.
