## DISBURSEMENT AND SUBROGATION AGREEMENT

THIS INDENTURE, made this 23 day of December, 1977, by and between John M. Mosby and Marilyn J. Mosby (hereinafter referred to as Mortgagor) and CONNECTICUT MUTUAL LIFE INSURANCE COMPANY, a Connecticut corporation (hereinafter referred to as Mortgagee;

WITNESSETH THAT:

WHEREAS, Mortgagor is the owner in fee simple of the premises described in Exhibit "A" attached hereto and made a part hereof, which premises are hereinafter referred to as "the mortgaged premises", and,

WHEREAS, Mortgagor holds title to the mortgaged premises subject to a certain Mortgage dated December 20, 1969 in favor of Walter J. Lucas and Alice J. Lucas, husband and wife, Mortgagee, and recorded in Official Records of Klamath County, Oregon on December 31, 1969 in Vol. M-69 page 10850-10856 to secure a Note dated September 1, 1969, in the original principal sum of \$210,000 payable as therein stated, made by Investors Acquisition Corporation, Bert E. Swanston and Suzanne E. Swanston, Mortgagor; said Note and Mortgage hereinafter referred to as the Senior Mortgage; and,

WHEREAS, Mortgagor has executed and delivered unto Mortgagee a certain Mortgage dated December , 1977 and recorded simultaneously herewith, to secure a Note of even date in the amount of ONE MILLION TWO HUNDRED THOUSAND AND NO/100 DOLLARS (\$1,200,000.00) and interest and other charges therein described (hereinafter referred to as "Current Mortgage"), which Note is held by Mortgagee, and,

WHEREAS, all of the money secured by the Current Mortgage filed simultaneously herewith has not yet been advanced but is to be advanced by the legal holder and owner of the indebtedness and Note secured by said Current Mortgage pursuant to the terms thereof and to be applied from time to time to the payment of the remainder of the unpaid indebtedness secured by the Senior Mortgage in accordance with the terms thereof.

NOW, THEREFORE, in consideration of the premises and of the making of the Current Mortgage, filed simultaneously herewith, Mortgagor does hereby authorize and empower the legal holder and owner from time to time, of the Note secured by the Current Mortgage, to disburse the funds secured by said Current Mortgage and to apply the same from time to time to the payment of part or all of the principal and interest secured by the Senior Mortgage in accordance with the terms thereof, and it is expressly covenanted and agreed by the parties hereto, that upon each such payment;

25065 - 2 the owner of the indebtedness secured by the Current Mortgage shall be and is hereby subrogated to all rights, liens and privileges which before such payment were vested in the owner or legal holder of the indebtedness secured by the Senior Mortgage and upon such payment the Current Mortgage shall be for all intents and purposes and to the extent of payments so made a first and valid lien, subrogated as aforesaid, upon the premises above described. THIS AGREEMENT is binding upon the heirs, representatives, administrators, successors and assigns of the parties hereto.
