RELEASE OF MORTGAGE

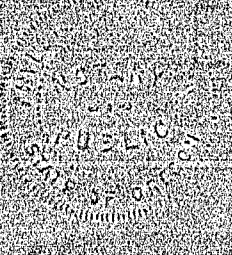
