THIS AGREEMENT, made this 30th day of November, 1977, between ALFRED L. KREUSCH and LENA KREUSCH, husband and wife, and FRANK F. GANONG and WILLIAM GANONG, JR., in their individual capacities and as Trustees of William Ganong Testamentary Trust B,

W I T N E S S E T H:

1.

The Parties hereto each own real property in Section 35, Twp. 35 S., R. 14 E., W.M., Klamath County, Oregon, which have access to and from the United States Forest Service Road No. 335 commonly known as the Weyerhaeuser Road and the Boulder Creek Road on a presently existing Private Road which passes over a part of each of said Parties' said Lands.

2.

Each of the Parties to this Agreement do hereby give and grant unto the other Parties to this Agreement a perpetual easement to be appurtenant to said Parties' respective Lands in said Section 35 for ingress and egress to and from said Lands and said Forest Service Road upon said existing Private Road and each of the Parties reserve and retain the like right to use the easement granted to the other Parties herein.

3.

The purpose of this Agreement is to confirm, evidence, and perpetuate the right of each of the Parties to this Agreement and their respective heirs, devisees, successors, and grantees to the use of said existing Private Road and nothing in this Agreement shall be deemed or construed to grant unto the Public any right in or use of said existing Private Road. Any of the Parties to this Agreement may install and maintain gates across said Private Road where it crosses their respective Lands but shall furnish the other Parties with a key to said gate if they wish it kept locked.
