NOW THEREFORE, in consideration of the premises and of the promises and agreements hereinafter contained,

E the parties hereto do hereby agree that the balance now due and owing on the promissory note hereinabove described. shall be and is payable in monthly installments of ______ Two Hundred Fifty and No/100.

(\$ 250.00) DOLLARS each, including interest on the unpaid balance at the rate of <u>10.0</u>% per annum. The first installment shall be and is payable on the 18 day of BJ Feb. , 19.78 , and a like installment on the 18 day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest if not sooner paid, shall be due and payable on the <u>10</u> day of <u>January</u>, <u>19</u>. If any of said installments of either principal or interest are not so paid, the entire balance then owing shall, at the option of the Mortgagee or its successors in interest, become immediately due and payable without notice.

Except as herein modified in the manner and on the terms and conditions hereinabove stated, the said promissory note and mortgage shall be and remain in full force and effect, with all the terms and conditions of which the mortgagor(s) do agree to comply in the same manner and to the same extent as though the provisions thereof were in all respects incorporated herein and made a part of this agreement.
