

NOTICE OF ATTORNEY'S LIEN

KNOW ALL MEN BY THESE PRESENTS: The undersigned, hereinafter called the claimant, has performed legal services as an attorney at law on behalf of Louise C. Oden at her special instance and request in Klamath County Circuit Court case No. 77-361E and is owed therefor the sum of \$500.80.
