

BLANKET SURRENDER AND QUITCLAIM

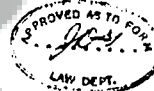

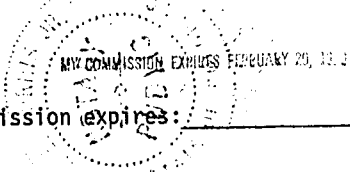
