TERMINATION OF LEASE BY MUTUAL CONSENT

WHEREAS, on September 13, 1954, JAMES H. WILSON, as Lessor, and TIDEWATER OIL COMPANY, a Delaware corporation (formerly TIDE WATER ASSOCIATED OIL COMPANY), as Lessee, executed a certain Lease covering all that certain property situate in the County of Klamath, State of Oregon, as more specifically described therein, which Lease was amended and extended by an Extension Agreement, between the parties, dated August 1, 1962, and was recorded on December 31, 1962, in Volume 342, at Page 226 of Deed Records of Klamath County, Oregon, and reference to which is here made for all purposes; and

WHEREAS, JAMES H. WILSON and ALICE B. WILSON, his wife, as tenants by the entireties with right of survivorship, acquired Lessor's interest in said Lease by a Deed dated January 7, 1953, recorded July 21, 1953, in Volume 262, at Page 98, Deed Records, Klamath County, Oregon; and

WHEREAS, ALICE B. WILSON acquired Lessor's interest in said Lease upon the demise of JAMES H. WILSON on June 28, 1971; and

WHEREAS, ELDON D. PETERSON, acquired Lessor's interest in said Lease by Assignment Agreement dated September 6, 1973; and

WHEREAS, ROBERT E. VEATCH executed a Contract for Deed dated December 19, 1977; and

WHEREAS PHILLIPS PETROLEUM COMPANY, a Delaware corporation, acquired the Lessee's interest in said Lease by an unrecorded Assignment Agreement dated June 8, 1966; and

WHEREAS, THE OIL SHALE CORPORATION, a Nevada corporation, acquired the Lessee's interest in said Lease by Assignment of Leases dated February 2, 1976, recorded April 1, 1976, in Volume M-76, at Page 4543, Deed Records Klamath County, Oregon; and

WHEREAS, LION OIL COMPANY, a Delaware corporation, acquired Lessee's interest in said Lease by Assignment of Leases dated February 2, 1976, recorded April 1, 1976, in Volume M-76, at Page 4545, Deed Records Klamath County, Oregon; and

WHEREAS it is the desire and intent of Robert E. Veatch and Eldon D. Peterson and Lion Oil Company to terminate said Lease (including all supplements thereto, modifications and extensions thereof), as hereinafter set forth:

NOW, THEREFORE, Robert E. Veatch and Eldon D. Peterson and Lion Oil Company, do hereby mutually agree that said Lease together with any supplements thereto, modifications and extensions thereof, shall be and is hereby terminated effective the <u>31st</u> day of <u>December</u>, 1977, and the parties hereto are released from all obligations thereunder except rental, if any, accruing prior to said date.
