## KNOW ALL MEN BY THESE PRESENTS, That

HENRY T. HOLMAN

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by ROBERT G. GRAY and LINDA GRAY, husband and wife, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Lot 4 Block 2, SUNBURST ESTATES, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

## SUBJECT TO:

1. Rights of the public in and to any portion of the herein described premises lying within the limits of streets, roads or highways.
2. Reservations, including the terms and provisions thereof, as contained in Deed recorded January 22, 1958 in Volume 297 at page 113, Deed Records of Klamath County, Oregon, to wit:  
" Subject to such rights for road purposes as the County of Klamath, Oregon, may have under the Act of February 5, 1946 (62 Stat. 17).

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever.

And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$30,620.00.
