MEMORANDUM OF LEASE

2 This is a memorandum of a certain unrecorded lease dated the 1st day of 8 January, 1978, between Swan Lake Moulding Company, an Oregon Corporation, as Lessor, and C.S.P. Corp., an Oregon Corporation, as Lessee, concerning the following decribed real property situated in Klamath County, Oregon, to-wit: Б 6

PARCEL 7: Starting at the Northwest corner of Section 3, Township 39 South, Range 9 East of the Willemette Meridian, Klamath County, Oregon, and running thence South CO<sup>O</sup>00<sup>1</sup>/<sub>2</sub> East along the Westerly boundary of Section 3, 977.8 feet, more or less, to a line parallel with and 50 feet distant at right angles Southwesterly from the center line of the Dalles-California Highway, also known as South Sixth Street, as the same is now located and constructed; thence South 550522' East along said parallel line 1326.6 feet; thence at right angles to South Sixth Street South  $3l_{2}^{0072}$ . West 150 feet to Point F and the true beginning point of this description from which a cross chiseled in the concrete sidewalk bears North 340072' East 161 feet; thence from said true beginning point South  $55^{\circ}52\frac{1}{2}$ ' East parallel to South Sixth Street 70 feet to point E; thence South  $34^{\circ}07\frac{1}{2}$ ' West 44 feet to point G; thence North 550522 West 70 feet to point H; thence North 340072 East 14 feet to the true point of beginning.

PARCEL 8: Beginning at said point F; thence North 55°52½! West 75 feet; thence South 34°07½! West 14 feet; thence South 55°52½! East 75 feet; thence North 34°07½! East 44 feet to the point of beginning.

For good and valuable consideration, Lessor leased the premises described as Parcel 7 above to the Lessee, together with the non-exclusive right of ingress and egress over the above-mentioned Parcel 8, and service roads to South Sixth Street, and also the non-exclusive right to park cars on the Easterly and Westerly sides of Parcel 8 leaving the center clear for two-way traffic. The term of the lease is for a period of 25 years, commencing on the execution of the lease.

This memorandum is not a complete summary of the lease. Provisions in the memorandum shall not be used in interpreting the lease provisions. In the event of a conflict between the memorandum and the unrecorded lease, the unrecorded lease shall control.
