KNOW ALL MEN BY THESE PRESENTS, That Winema Peninsula Inc., an Oregon corporation,

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by Diane Ruth Taylor aka Diane Ruth Douglas, hereinafter called

the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit: Lot 28 in Block 7 of Tract No. 1019, WINEMA PENINSULA UNIT NO. 2, Klamath County, Oregon.

Subject, however, to the following:

1. An easement created by instrument, including the terms and provisions thereof, Recorded : February 27, 1959 Book: 310 Page 175 In favor of : Klamath Telephone & Telegraph Company For : Telephone & Telegraph line.
2. Restrictions, but omitting restrictions, if any, based on race, color, religion or national origin, as shown on the recorded plat of Winema Peninsula Unit No. 2.
3. Set back provisions as delineated on the recorded plat, 25 foot set back lines along front and 20 foot along all side and back lot lines.
4. Utility easements as delineated on the recorded plat along all back and side lot lines.

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever.

And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except as noted of record as of the date of this deed and those apparent upon the land, if any, as of the date of this deed,

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 2,800.00
