WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That MELVIN G. GORDON and VIRGINIA GORDON, husband and wife,

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by DAVID M. ORMSBY and VALERIE G. ORMSBY, husband and wife, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit: Beginning at the Northwest corner of Lot 18 of Block 6 in ST. FRANCIS PARK and running thence South along the West line of said lot, 46 feet 8 inches to an iron pin which marks the true point of beginning; thence East to an iron pin on the East line of Lot 15 in said Block 6 which is 46'8" South from the Northeast corner of said Lot 15; thence South along the East line of said Lot 15 a distance of 46'8" to an iron pin; thence West to an iron pin on the West line of Lot 18 which is South along said West line a distance of 46'8" from the point of beginning; thence North along the West line of said Lot 18 to the point of beginning; all being the center 46'8" of Lots 15 through 18 in Block 6 in ST. FRANCIS PARK.

SUBJECT TO: All future real property taxes & assessments; reservations, restrictions, easements and rights of way of record, and those apparent on the land; regulations, including levies, assessments, water & irrigation rights & easements for ditches and canals, of Enterprise Irrigation District;

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever.

And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except as above set forth, and, Regulations, including levies, liens, assessments, rights of way and easements of the South Suburban Sanitary District,

and that

grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 8,000.00
