## BOUNDARY SETTLEMENT AGREEMENT

THIS AGREEMENT made and entered into this 2nd day of March, 1978,  
by and between the undersigned adjoining property owners.

## WITNESSETH:

WHEREAS said parties owned land adjoining each other; and

WHEREAS CLIFFORD A. THOMAS owns a tract of land described as Lot 1 of  
Casitas, according to the official plat thereof on file in the office of  
the County Clerk of Klamath County, Oregon; and

WHEREAS ELLEN R. REED owns a tract of land containing 1.73 acres,  
more or less, situated in Lot 11, Block 3, SECOND ADDITION TO ALTAMONT  
ACRES; as shown in Recorded Survey No. 2569 on file in the office of the  
County Surveyor of Klamath County, Oregon; and

WHEREAS the existing fence line as seen between said properties as  
confirmed by survey of WAYNE C. CHURCH establishes the existing boundary  
between said properties.

IT IS HEREBY agreed that the boundary between said properties shall be  
beginning at a 5/8 inch iron rod at the Southwest corner of said Lot 11,  
Block 3, SECOND ADDITION TO ALTAMONT ACRES as shown in said Recorded Survey  
No. 2569: thence N 0° 14' W 164.50 feet to a 1 1/2 inch iron rod on the west  
line of said Lot 11 being the Northwest corner of tract of land owned by  
ELLEN R. REED and the end of this boundary. And the fence line existing  
upon said property and along said line is hereby ratified and confirmed as  
the boundary line between the two tracts.
