KNOW ALL MEN BY THESE PRESENTS, That ROBERT B. COULTER and MARILYN B.

COULTER, husband and wife,
 hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by PAUL D. JACKSON
 and LOIS E. JACKSON, husband and wife,
 the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Lot 4, Block 3, EASTMOUNT, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

SUBJECT TO:

1. Statutory powers, including the power of assessment of Enterprise Irrigation District.
2. Statutory powers, including the power of assessment of So. Suburban Sanitary Dist.
3. Sewer and utility easement as shown on dedicated plat.
4. Restrictions as contained in plat dedication.
