Klamath County Planning FINDINGS OF FACT AND ORDER

A hearing was held in this matter at Klamath Falls, Oregon, on March 15, 1978, pursuant to notice given in conformity with Ordinance No. 35, Klamath County, before Klamath County Hearings Officer, Jim Spindor. The applicant was present, accompanied by Alan Prescott, his father. The Klamath County Planning Department was represented by Carl Shuck. The Hearings Reporter was Isabel Rodriguez.

Evidence was presented on behalf of the Department and on behalf of the applicant. There were no adjacent property owners present who stated they had any objections to the proposed Variance requested by the applicant.

There are exceptional circumstances that apply to this property not applicable to other porperty in the area, and that is the fact of the way the property is presently being used for farm use; the Variance is necessary for the particular use. It is necessary to preserve the right to have a potato shed on the property which is necessary for the operation.
