PARCEL 1: Section 4,  $S\frac{1}{2}SW\frac{1}{4}SE\frac{1}{4}$ ; Section 5,  $SW\frac{1}{4}$ ; Section 8, All except  $NW\frac{1}{4}$ ; Section 9, All; Section 13, Government Lots 1, 2, 7, 8, 9, 10, 15 and 16; Section 16, All; Section 17, All; Section 21,  $N\frac{1}{2}$ ,  $SW\frac{1}{4}$ ,  $NE\frac{1}{4}$ ,  $W\frac{1}{2}SE\frac{1}{4}$ ; Section 22,  $W\frac{1}{2}$ ; Section 27,  $NW\frac{1}{4}$ ; Section 28,  $E\frac{1}{2}NE\frac{1}{4}$ ; Government Lots 20, 21, 22 and 23, Block 14, Sprague River, in the County of Klamath, State of Oregon. All portions in Township 36 South, Range 10 East of the Willamette Meridian in the County of Klamath, State of Oregon.

PARCEL 2: Section 8,  $NW\frac{1}{4}$ ; All portions in Township 36 South, Range 10 East of the Willamette Meridian, in the County of Klamath, State of Oregon.

PARCEL 3: A tract of land lying in Lot 14 (in the  $SE\frac{1}{4}$  of the  $NW\frac{1}{4}$ ) Section 14, Township 36 South, Range 10 East of the Willamette Meridian, in the County of Klamath, State of Oregon, more particularly described as follows: Beginning at a point which lies South along the Section line a distance of 1980 feet, and East a distance of 1753 feet, and South a distance of 100 feet from the iron pin which marks the Northwest corner of Section 14, in Township 36 South, Range 10 East of the Willamette Meridian, and running thence South 100 feet; thence East 120 feet; thence North 100 feet; thence West 120 feet, more or less, to the point of beginning.
