A tract of land situated in the N₂SE₁ of Sec. 9, T. 39 S., R. 10 E., W.M., Klamath County, Oregon, more particularly described as follows:
 Beginning at a point located S 0°08' W a distance of 668.25 feet and N 89°52' W a distance of 30.00 feet from the east $\frac{1}{4}$ corner of said Section 9; thence N 89°52' W a distance of 436.05 feet to an iron pin; thence S. 0°08' W parallel with the east line of said Section 9 a distance of 667.84 feet to an iron pin on the south line of the N₂SE₁ of said Section 9; thence S 89°43' E along the south line of the N₂SE₁ of said Section 9 a distance of 436.05 feet; thence N 0°08' E parallel with the east line of said Section 9 a distance of 668.21 feet, more or less, to the point of beginning.
