5 1. The property is adequate in size and shape for the proposed use; it is approximately 11,790 square feet in size. The 6 plot plan has indicated that the applicant can meet the required setbacks of the RD 10,000 (Single Family Residential) Zone. 8 0

2. There is adequate access from LaVerne Street which appears that it will be able to carry the quantity of traffic 10 that would be generated by the proposed use. 11

12 3. The site is adjacent to other lots in the area of a 13 mixed nature, some of mobile homes and some of older conventional 14 homes.

4. There would be no adverse affect by allowing the 16 Conditional Use Permit in an established neighborhood.

There are no conditions deemed necessary to protect 5 the public health, safety, convenience, or welfare. 18

The Hearings Officer, based on the foregoing Findings of 20 Fact, accordingly orders as follows:
