## CERTIFICATE OF WATER RIGHT

This Is to Certify, That R. S. DIXON

of Fort Klamath  
proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of  
Anna Creek

a tributary of Wood River  
the irrigation of 219.5 acres

for the purpose of

under Permit No. 8028 and that said right to the use of said waters has been perfected in  
accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from  
June 25, 1927  
that the amount of water to which such right is entitled and hereby confirmed, for the purposes  
aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed  
2.74 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.  
The point of diversion is located in the SW $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 31, T. 32 S., R. 7 $\frac{1}{2}$  E., W. M.

The amount of water used for irrigation, together with the amount secured under any other  
right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second  
per acre,

conform to such reasonable rotation system as may be ordered by the proper state officer, and shall
