together with the tenements, hereditaments, rights, privileges, and appurtenances including roads and easements used in connection with the premises; electric wiring and fixtures; furnace and heating system, water heaters, fuel storage receptacles; plumbing, ventilating, water and irrigating systems; screens, doors; window shades and blinds, shutters; cabinets, built-ins, linoleums and floor coverings, built-in, stoves, ovens, electric sinks, air conditioners, refrigerators, freezers, dishwashers; and all fixtures now or hereafter replacements of any one or more of the foregoing items, in whole or in part, all of which are hereby declared to be appurtenant to the

I promise to pay to the STATE OF OREGON: Eleven Thousand Seven Hundred Thirty Six and no/100---- Dollars (\$11,736.00--), with interest from the date of initial disbursement by the State of Oregon, at the rate of 5.9------ percent per annum, Twenty Seven Thousand Two Hundred Seventy Two and 71/1/Qbollars (\$27,272.71--7, with interest from the date of initial disbursement by the State of Oregon, at the rate of 5.9----Dollars (\$\_\_\_\_\_\_), with percent per annum, interest from the date of initial disbursement by the State of Oregon, at the rate of until such time as a different interest rate is established pursuant to ORS 407.072, principal and interest to be paid in lawful money of the United States at the office of the Director of Veterans' Affairs in Salem, Oregon, as follows: \$ 232,00----- on or before April 1, 1978----- and the ad valorem taxes for each successive year on the premises described in the mortgage, and continuing until the full amount of the principal, interest and advances shall be fully paid, such payments to be applied first as interest on the unpaid principal, the remainder on the principal. The due date of the last payment shall be on or before March 1, 2008 Dated at Klamath Falls, Oregon

The mortgagor or subsequent owner may pay all or any part of the loan at any time without penalty.

This mortgage is given in conjunction with and supplementary to that certain mortgage by the mortgagors herein to the State of Oregon, dated October 14, 1975, and recorded in Book M-77, page 23133; Mortgage Decords for Klaimatis County, Oregon, which was given to secure the payment of a note in the amount of \$200,00, and this mortgage is also given as security for an additional advance in the amount of \$ 11,736.00, together with the balance of indebtedness covered by the previous note, and life new note is evidence of the entire indebtedness.

The morigagor covenants that he owns the premises in fee simple, has good right to murigage same, that the premises are free from encumbrance, that he will warrant and defend same forever against the claims and demands of all persons whomsoever, and this covenant shall not be extinguished by foreclosure, but shall run with the land.

MORTGAGOR FURTHER COVENANTS AND AGREES:

- To pay all delits and moneys secured hereby;
- Not to permit the buildings to become vacant or unoccupied, not to permit the removal or demailshment of any buildings or improvements now or hereafter existing; to keep same in good repair, to complete all construction within a reasonable time in accordance with any agreement made between the parties hereto; accordance with any agreement made netween the parties hereio.

  3. Not to permit the cutting or removal of any timber except for his own domestic use; not to commit or suffer any waste:

  - Not to permit any tax, assessment, lien, or encumbrance to exist at any time;
  - Mortgagee is authorized to pay all real property taxes assessed against the premises and add same to the principal, each of the advances to bear interest as provided in the note;
  - advances to bear interest as provided in the note;

    To keep all buildings unceasingly insured during the term of the mortgage, against loss by fire and such other hazards in such company or companies and in such an amount as shall be satisfactory to the mortgagee; to deposit with the mortgage all such policies with receipts showing payment in full of all premiums; all such insurance shall be made payable to the mortgage incase of foreclosure until the period of redemption expires.

- Mortgagee shall be entitled to all compensation and damages received under right of eminent domain, or for any security voluntarily released, same to be applied upon the indebtedness;
- 9. Not to lease or rent the premises, or any part of same, without written consent of the mortgagee;
- 10. To promptly notify mortgagee in writing of a transfer of ownership of the premises or any part or interest in same, and to furnish a copy of the instrument of transfer to the mortgagee; a purchaser shall pay interest as prescribed by ORS 407 070 on a payments due from the date of transfer; in all other respects this mortgage shall remain in full force and effect.

The mortgagee may, at his option, in case of default of the mortgagor, perform same in whole or in part and all expenditures nade in so doing including the employment of an attorney to secure compliance with the terms of the mortgage or the note shall lemand and shall be secured by this mortgage, without expenditures shall be immediately repayable by the mortgager without

Default in any of the covenants or agreements herein contained or the expenditure of any portion of the loan for purposes of the mortgage given before the expenditure is made, mortgage subject to foreclosure.
