1. The Applicant has failed to show that there is a need for such an activity in the area. 6 7

2. Before any further consideration for this request will be made, the applicant must present to the Planning Depart-8 ment a complete proposal of the plan for the area. This proposal 9 should include such items as a fencing proposal, mosquito control 10 in the area, a showing of adequate resources, and that the 11 applicant has complied with the Department of Geology and Mineral 12 13 Industries.

14 The Hearings Officer, based on the foregoing Findings of Fact, accordingly orders as follows: 15
