hereinafter called grantee, and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any-wise appertaining, situated in the County of Klamath

PARCEL 1: Section 4, S $\frac{1}{2}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$; Section 5, SW $\frac{1}{4}$; Section 8, All except NW $\frac{1}{4}$; Section 9, All; Section 13, Government Lots 1, 2, 7, 8, 9, 10, 15 and 16; Section 16, All; Section 17, All; Section 21, N $\frac{1}{2}$ N $\frac{1}{2}$, SW $\frac{1}{4}$ NE $\frac{1}{4}$, W $\frac{1}{2}$ SE $\frac{1}{4}$; Section 22, W $\frac{1}{2}$ W $\frac{1}{2}$; Section 27, NW $\frac{1}{4}$ NW $\frac{1}{4}$; Section 28, E $\frac{1}{2}$ E $\frac{1}{2}$ NE $\frac{1}{4}$; Government Lots 20, 21, 22 and 23, Block 14, Sprague River, in the County of Klamath, State of Oregon.
