- 3. DESCRIPTION OF PROPERTY:

A portion of Lot 8, Section 6, Township 40 South, Range 8 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at a point on the East line of Lot 8, Section 6, Township 40 South, Range 8 E.W.M. 660.00 feet South from the Northeast corner of said Lot 8; thence West at right angles to said East line of said Lot 8 to a point on the easterly line of Keno-Worden Highway and the point of beginning of this description; thence Northwesterly along said Easterly line of said Highway 160.00 feet; thence East 200.00 feet; thence Southeasterly parallel with and 200.00 feet from the Keno-Worden Highway 160.00 feet; thence West 200.00 feet to said Highway right of way and point of beginning of this description.

Edwards and William F. and Michele Jackson, Mortgagors, to Klamath Falls Branch of Western Bank of Coos Bay, Oregon, Mortgagee, dated August 26, 1977, recorded in the mortgage records of Klamath County in book M77 at page 16133. Said mortgage secures a promissory note in the principal sum of \$40,000 on which a balance of \$37,876.21 is owing as of May 1, 1978, together with interest from April 18, 1978.

(b) A prior mortgage made by Ward L. and Betty L. Edwards and William F. and Michele Jackson, Mortgagors, to Klamath Falls Branch of Western Bank of Coos Bay, Oregon, Mortgagee, dated December 19, 1977, recorded in the mortgage records of Klamath County in book M77 at page 24919, said mortgage secures a promissory note in the principal sum of \$100,000 on which a balance of \$98,886.22 is owing as of May 1, 1978, together with interest from April 25, 1978.

4. TERMS OF MORTGAGE: This Mortgage is security for a promissory note in the amount of \$36,000 payable to Mortgagee in monthly installments of not less than \$347.41 each, including interest at the rate of 10 percent per annum, due the 25th day of each month beginning May 25, 1978, until the whole sum, including principal and interest, is paid in full, the final payment being due and payable on April 25, 1998.
