WARRANTY DEED

A parcel of land lying in Block C, HOMECREST, Klamath County, Oregon and being a portion of that property described in that deed to Profit Sharing Pension and Trust of Aladdin's Valley Rental Service, Inc., recorded in Book M-73, Page 16082 of Klamath County Record of Deeds; the said parcel being that portion of said property included in a strip of land 30 feet in width, lying on the Southerly side of the center line of Shasta Way as said Shasta Way has been relocated, which center line is described as follows:

Beginning at Engineer's center line Station 44+15, said station being 29.52 feet South and 2879.86 feet East of the Southwest corner of Section 34, Township 38 South, Range 9 East, W.M.; thence South 89° 42' 40" East 835 feet to Engineer's center line Station 52+50.
