KNOW ALL MEN BY THESE PRESENTS, That

And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances EXCEPT: 1. Regulations of Klamath Project and Klamath Irrigation District. 2. Regulations of South Suburban Sanitary District. 3. Reservations, restrictions and easements as contained in plat dedication. and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$45,000.00.
