True and Lawful Attorney


and for my use and benefit, for me and in my name place and stead,

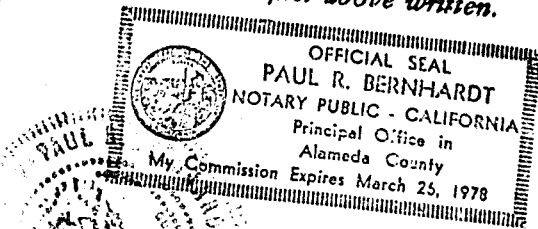
