KNOW ALL MEN BY THESE PRESENTS, That Bell Family Trust

hereinafter called the grantor, for the consideration hereinafter stated to the grantor paid by Roderick L. Slade and Elizabeth A. Slade, husband and wife, hereinafter called the grantees, does hereby grant, bargain, sell and convey unto the grantees, as tenants by the entirety, the heirs of the survivor and their assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Linn, State of Oregon, described as follows, to-wit:

Lots 13 and 14 of OUSE KILA HOME SITES, in the County of Klamath, State of Oregon.

Subject, however, to the following:  
 1. Reservations and restrictions, as shown in deed from R. P. Oliver, et ux., to Raymond H. Reeves, et ux., dated May 27, 1930, recorded in Book 103 at page 185, Deed Records of Klamath County, Oregon, on June 20, 1934.  
 2. Easements and releases and rights of way deeded to The California Oregon Power Company, a California Corporation, as recorded in Book 68 at page 277, to 281, inclusive and in Book 105, pages 226-227, all in Deed Records of Klamath County, Oregon.

To Have and to Hold the above described and granted premises unto the said grantees, as tenants by the entirety, their heirs and assigns forever.
