Bidegary, Husband and Wife MYMOND GENE BIDEGARY herein referred to as Mortgagor, and SECURITY SAVINGS AND LOAN ASSOCIATION, an Oregon Corporation, at Klamath Falls, Oregon, hereinafter referred to as Mortgagee.
