The hearing was then closed, and based upon the evidence 1 submitted at the hearing, the Hearings Officer made the following 2 findings of fact: 3 FINDINGS OF FACT: 4 There are exceptional and extraordinary circum-5 1. stances in that the present garage is not adequate in size to 6 serve a purpose as a garage; and it is also an exceptional circum-7 stance in that it has a lateral running through the lot, and to 8 meet the setback requirements, the applicant would have to place 9 the garage in a position that would not be adequate. 10 The granting of the Variance is necessary to allow 11 2. the preservation of the applicant's right to have protection for 12 his vehicle, a right that is possessed by other property owners 13 14 in the area. There was no testimony in opposition to the grant-15 3. ing of this Variance. 16 4. There would be no detrimental affects on the public 17 health, safety, or convenience or welfare by the granting of this 18 19 Variance. The requested Variance is the minimum Variance 20 5. which is required to alleviate the hardship. 21 This Variance will not allow use of the property 22 6. for a purpose which is not authorized in the zone. 23 The Hearings Officer, based on the foregoing Findings 24 of Fact, accordingly orders as follows: 25That real property described as the 26 "parcel of land approximately 42,898 27 square feet in size and generally located 640 feet south of Hilyard 28

Avenue and approximately 475 feet north of Onyx Avenue with the F-7 Lateral running through the property and more particularly described as situated in Altamont Acres Subdivision, Lot 15, Block 5, on South Suburban Sheet No. 1, Klamath County, Oregon"

is hereby granted a Variance in accordance with the terms of the Klamath County Zoning Ordinance No. 17 and henceforth the required front yard setback will be reduced from 25 feet to 15 feet for the purpose of placing a garage on the lot.
