5 1. The site is adequate in size and shape to house the proposed activity, and that it does fit in with the neighborhood 6 7 as shown by the fact that there are other mobile homes in the 8 immediately area.

9 The site has adequate access to the streets and 2. 10 highways to carry the traffic flow which will be generated from 11 this particular use.

12 There would be no adverse affects on the abutting 3. 13 property owners.

14 There was no testimony in objection to the granting 5. 15 of this Conditional Use Permit.

16 The Hearings Officer, based on the foregoing Findings of Fact accordingly orders as follows: 17

That real property described as the

"parcel of land approximately 17,940 square feet in size generally located east of West Side Road and more particularly described as situated in Lot 5 and 6, Block 2 of Evergreen Acres Subdivision, Section 10, Township 36 South, Range 6 East of the Willamette Meridian, Klamath County, Oregon."
