

A D D E N D U M

THIS ADDENDUM made and entered into this 28th day of June, 1978, by and between KLAMATH COUNTY and VERNON O. NORVALL and MARY C. NORVALL, in respect to that certain lease entered into between KLAMATH COUNTY and VERNON O. NORVALL and MARY C. NORVALL dated June 6, 1978: Paragraph 2 of the original lease is hereby amended as follows:

Rental and Term. The lease shall be for one year commencing on the 15th day of June 1978, and ending on Midnight on the 14th day of June, 1979. Lessors further grant to Lessee an option to renew for the further period from 12:01 A.M. on June 15, 1979, and ending at Midnight on the 14th day of June, 1982. Lessee shall pay Lessors the sum of \$900 as and for lease payments due under the original lease and the further sum of \$2,700 for the lease extension in the event the lease option granted herein is exercised. Such payments shall consist of \$75.00 on execution of this lease as and for the first month's rent, with the additional sum of \$75.00 as monthly rental payment which shall be due beginning July 15, 1978. Lessee may at any time but in no event later than May 15, 1979, give notice in writing of its intention to exercise the lease option which shall be personally delivered to lessors or sent by first class mail to the lessors at the last given address of the lessors. Notice shall be deemed given when posted in the mails.
