PARKER, husband and wife, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath, and State of Oregon, described as follows, to-wit:

2. Reservations as contained in plat dedication.
3. Covenants and restrictions, recorded March 15, 1977 in Volume M77, page 4361, Microfilm Records of Klamath County, Oregon.
4. An 8 foot utility easement over Southwesterly portion of Lot 4 as shown on dedicated plat.
5. Taxes for the fiscal year 1976-79, a lien, but not yet due and payable.

And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except as set forth above and apparent upon the land,

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
