A parcel of land lying in the SE4 of Section 34, Township 38 South, Range 9 East, W.M., Klamath County, Oregon and being a portion of that property described in that deed to Klamath Falls KOA, Inc., recorded in Book M-75, Page 15218 of Klamath County Record of Deeds; the said parcel being that portion of said property included in a strip of land 35 feet in width, lying on the Northerly side of the center line of Shasta Way as said Shasta Way has been relocated, which center line is described as follows:

Beginning at Engineer's center line Station 44+15, at which station the Westerly line of said strip of land lies at right angles to said center line, said station being 29.52 feet South and 2879.86 feet East of the Southwest corner of Section 34, Township 38 South, Range 9 East, W.M.; thence South 89° 42' 40" East 835 feet to Engineer's center line Station 52+50.
