AGREEMENT FOR DOMESTIC WATER SUPPLY

WHEREAS, GEORGE MICKA and FLORENCE BEVERLY MICKA, husband and wife, Grantors, owners of the following described real property: All that part of the SW_4^1 SEC. 5, T. 41 S., R. 12 E.W.M., lying southerly cf and from the southern boundary line of the right-ofway on the lowland ditch of the Shasta View Irrigation District and containing 107.04 acres, more or less, subject to right-of-way for roads and ditches and said lands are in the Shasta View Irrigation District, Klamath County, Oregon,

in consideration of the sum of One and 00/100 Dollars (\$1.00), receipt of which is hereby acknowledged, hereby grant unto JAMES H. CAMPBELL and MARIETTA CAMPBELL, husband and wife, Grantees, the right of the Grantees to enter upon the lands of the Grantors for the purpose of maintaining the pipe line and pumping equipment.
