QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS, That Darrell Blackwell and Patricia Blackwell, husband and wife, hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and quitclaim unto Wallace W. Watkins,

hereinafter called grantee, and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

The NE^{1/4}SE^{1/4} of Section 19, Township 36 South, Range 13 East of the Willamette Meridian.

NOTE: The above description was erroneously included on the contract recorded May 8, 1978 in Microfilm M-78 at page 9299 (Garcia to Blackwell) and on the deed being held in escrow for collection. This Quitclaim Deed is being recorded to release any interest the Blackwells may have of record or may acquire upon the recording of the deed now held in escrow from Garcia.
