KNOW ALL MEN BY THESE PRESENTS, That JACK LAGE

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by MELODY M. YEE, a single person,

the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

A parcel of land in the NE $\frac{1}{4}$ SE $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 1, Township 40 South, Range 9 East, W.M., containing 1 acre, more or less, described as follows:

Beginning at a point in the section line marking the Easterly boundary of the said Section 1, 1151.8 feet Northerly from the one quarter section corner on the Easterly boundary of said Section 1; thence Westerly parallel with the East and West center line of said Section 1, 307 feet, more or less, to a point in the center of an irrigation ditch; thence Northerly along said ditch 148.2 feet, more or less, to a point in the Southerly boundary of the right of way of the U.S. Bureau of Reclamation lateral canal; thence Easterly along the said right of way boundary 307 feet, more or less, to a point in said section line marking the Easterly boundary of said Section 1; thence South along the said section line 148.2 feet, more or less, to the point of beginning: SAVING AND EXCEPTION therefrom any portion lying within the right of way of the Malin-Klamath Falls Highway.

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever.

And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances Mortgage, executed by Jack Lage to Edward C. and Marie E. Griffith, dated May 1, 1977 recorded April 28, 1977 in Mtg Vol M77 page 7231, records of Klamath County, Oregon, which mortgage buyer herein agrees to assume and pay.

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 35,000.00

In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.
