The S.W. 1/4, the S.E. 1/4, the S.W. 1/4 of Section 12, Township 38 South, Range 8 East of the Willamette Meridian, and the N.W. 1/4 of Section 13, Township 38 South, Range 8 East of the Willamette Meridian,
