SUBJECT TO: Easements and restrictions of record and those apparent on the land.

To Have and to Hold the same unto the said grantees and grantor's heirs, successors and assigns forever. And said grantor hereby covenants to and with said grantees and grantor's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances

grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
