authorized thereunto by order of its board of directors.

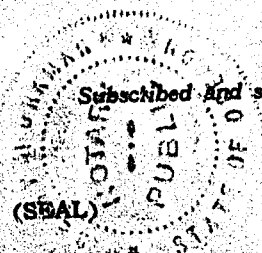
