I hereby ratify and confirm all lawful acts done and caused to be done by my said Attorney-in-Fact pursuant to this Power of Attorney and I direct that it shall continue in effect until the termination date herein specified unless sooner terminated by me or by operation of law.

No later than my insertion of a specific expiration date herein, I on said date I should be, or have been, carried in a military status of Missing in Action, Prisoner of War, or Status of Missing in Action, this Power of Attorney shall automatically continue to remain in full effect until sixty (60) days after I have returned to UNITED STATES MILITARY CONTROL following termination of my status.

If the authority contained herein shall be revoked or terminated by operation of law without notice, I hereby agree for myself, my heirs, administrators, heirs, and assigns, in consideration of my attorney's willingness to act pursuant to this Power of Attorney, to save and hold my attorney, his heirs, administrators, heirs, and assigns, from any loss suffered or any liability incurred by my attorney in so acting after such revocation or termination without notice.

(b) This Power of Attorney shall be null and void on and after 1 SEPT 1979.
