

C O N V E Y A N C E

WITNESSETH this indenture by and between Klamath County, Oregon, a subdivision of the State of Oregon, hereinafter referred to as "Grantor" and the United States of America, acting by and through the Forest Service of the United States Department of Agriculture, hereinafter referred to as the "Government".

WHEREAS, the Act of August 23, 1958 (68 Stat. 718; 72 Stat. 818) is further amended by adding a new Section 29 providing for the condemnation of the Klamath Indian Forest Lands, and the lands acquired shall become a part of the Winema National Forest, and;

WHEREAS, the lands being condemned are served by roads that were accepted by Klamath County as public roads with the usefulness and importance to the Government in connection with the multiple use and administration of the National Forest, and;

WHEREAS, the Government has determined which public roads it wishes to administer and maintain, and;

WHEREAS, Grantor has determined which public roads it wishes to transfer to the Government, and;

WHEREAS, it is desirable to clarify the status and responsibility for maintenance of said public roads.

NOW, THEREFORE, Grantor does hereby donate, remise, release and quitclaim unto the Government under ORS 271.330 (1), any right, title, or interest it may have or possess in or to the following described road, as further shown on the attached exhibit 1, and together with all related interests, including easements, rights-of-way and improvements situated in the County of Klamath, State of Oregon, to-wit:

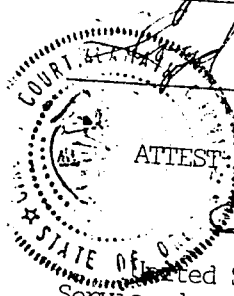

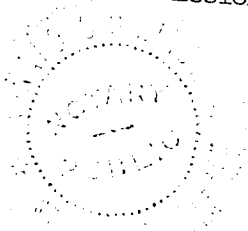

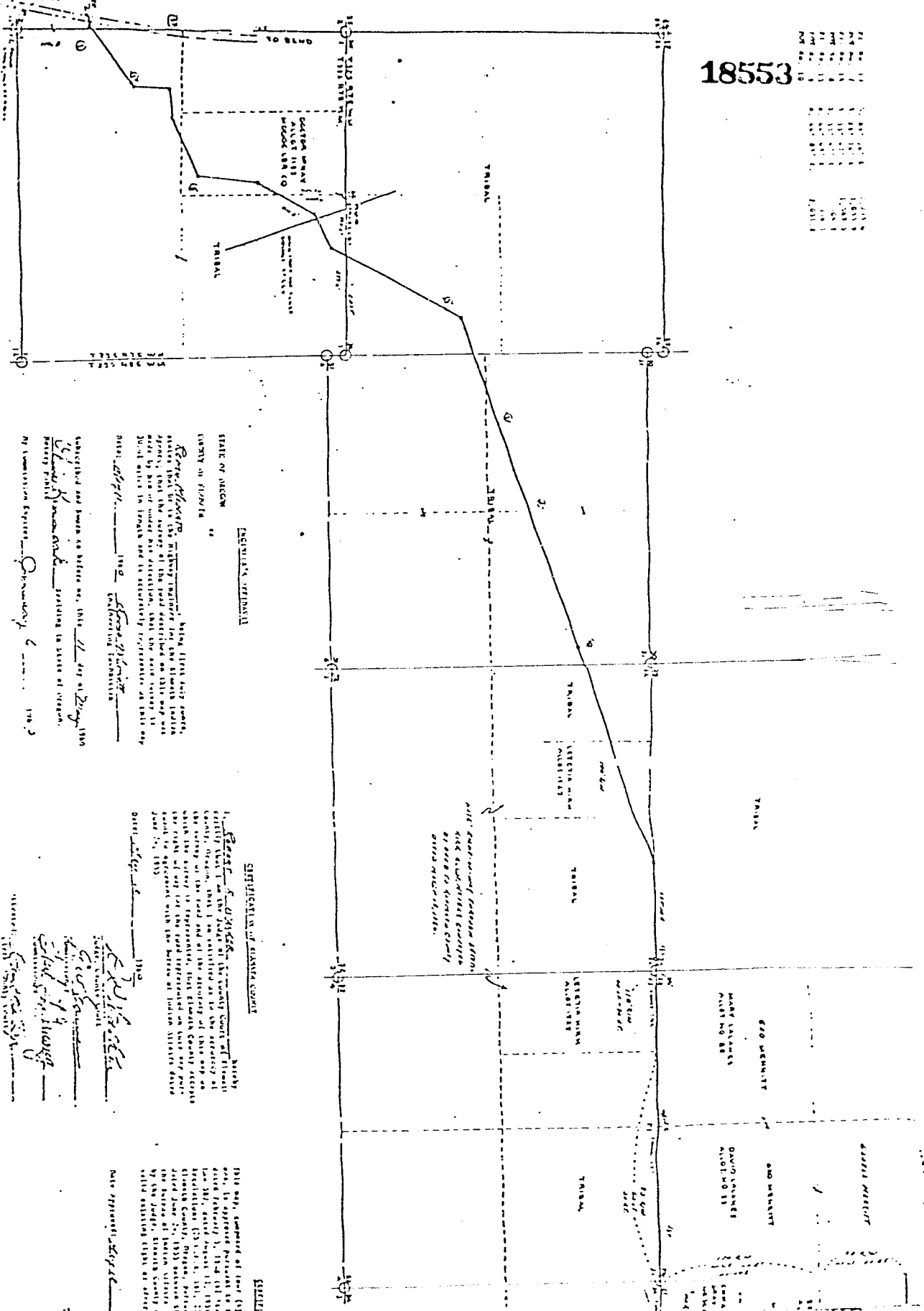
