HORTON and GRETA MAE HORTON, husband and wife, doing business as Indian Hills Ranch, Klamath County, Oregon, and their heirs and assigns, the following described easement upon the following described property in Klamath County, Oregon:

A ten (10) foot wide strip across the Langell Valley Irrigation District high line ditch, which said ditch is located in the SW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 25, Township 39 South, Range 11, E.W.M., said ten foot wide easement shall be located at a point on said high line ditch approximately 783 feet South of the Northern boundary of the SW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 25, Township 39 South, Range 11, E.W.M.

Said easement shall be for the purpose of transporting water across said high line ditch by means of a pipe and shall also include the right of access for the purpose of maintaining or repair of said pipe.
