A ten (10) foot wide strip across the Langell Valley Irrigation District high line ditch, which said ditch is located in the SW¹/₄ of the SE¹/₄ of Section 25, Township 39 South, Range 11, E.W.M., said ten foot wide easement shall be located at a point on said high line ditch approximately 783 feet South of the Northern boundary of the SW_4^1 of the SE_4^1 of Section 25, Township 39 South, Range 11, E.W.M.

Said easement shall be for the purpose of transporting water across said high line ditch by means of a pipe and shall also include the right of access for the purpose of maintaining or repair of said pipe.
