## FINDINGS OF FACT:

5 1. There are exceptional and extraordinary circumstances 6 which apply to this property which do not apply generally to other 7 property in the area in that there is three-fourths of an acre 8 which is cut away from the rest of the property and is confined by 9 its physical boundaries and that it does contain a residence and a 10 yard.

11 2. The granting of the Variance is necessary for the 12 preservation of the applicant's right to dispose of this piece of 13 property which he cannot use in his general farming operation.

14 3. No one testified in opposition to the Variance, and 15 there was no evidence suggesting that the Variance would be 16 detrimental to the effects of the public health or welfare.

17 4. The requested Variance to three-fourths of an acre
18 is the minimum Variance which would alleviate the hardship due
19 to the fact that the natural boundaries create this hardship.

20The Hearings Officer, based on the foregoing Findings21of Fact, accordingly orders as follows:

That real property described as the

"parcel of land generally located on the south side of the Old Dalles-California Highway, approximately one-fourth a mile east of Malin, with the 11-B-1 Drain bordering to the south of the property and more particularly described as Lots 3 and 6, Township 41 South, Range 12 East of the Willamette Meridian, Klamath County, Oregon"
